Driving Directions

Coming from the North

Merge onto I-5 S toward SEATTLE.
Take the Union Street Exit
Take the UNION ST. exit - EXIT 165B.
Stay STRAIGHT to go onto UNION ST.

Parking: In order of preference:

- 1) When driving down Union, just **BEFORE** you reach 4th Avenue, find the Rainier Square parking garage on your left. Notice: this is a paid parking garage.
- 2) When driving down Union, just **PAST** 4th Avenue, find the Key Bank parking garage on your left. Notice: this is a paid parking garage.

Coming from the South

Merge onto I-5 N toward SEATTLE.
Take the SENECA ST. exit - EXIT 165 - on the LEFT.
Turn SLIGHT LEFT onto SENECA ST.
Turn RIGHT onto 4TH AVE.
Turn LEFT onto UNION ST.

Parking: In order of preference

- 1) When driving down Union, just **BEFORE** you reach 4th Avenue, find the Rainier Square parking garage on your left. Notice: this is a paid parking garage.
- 2) When driving down Union, just **PAST** 4th Avenue, find the Key Bank parking garage on your left. Notice: this is a paid parking garage.

Coming from the East

From I-90 West:

Take the I-5 N exit - EXIT 2C

Stay in RIGHT hand lane

Take JAMES STREET exit (before reaching I-5 North)

Turn LEFT onto JAMES STREET

Turn RIGHT onto 4TH AVE.

Turn LEFT onto Union (stay in left hand lane and park at first left)

Parking:

- 1) Stay in left hand lane of Union Street; go a short distance (less than ½ block) and turn left into the Key Bank parking. Notice: this is a paid parking garage.

Walking Directions

From the Rainier Square Parking Garage:

After exiting the parking garage go to 4th Avenue. Look at the corners and find the Tully's store. We are in the same building that the Tully's is in. Go about a half a block past the Tully's store and up Fourth Avenue to the entrance of 1411. Walk into the 1411 building and take the elevator up to the 10th floor. We are in Suite 1010 at the end of the hall.

From the Key Bank Parking Garage:

After exiting the parking garage go to 4th Avenue. Look at the corners and find the Tully's store. We are in the same building that the Tully's is in. Go about a half a block past the Tully's store and up Fourth Avenue to the entrance of 1411. Walk into the 1411 building and take the elevator up to the 10th floor. We are in Suite 1010 at the end of the hall.
